7 **A Resolution authorizing the County Executive to advertise for bids for the removal and**  
8 **replacement of a heating/air conditioning five-zone unit system at the Engineer's main**  
9 **office facility, for an estimated total cost not to exceed \$70,000.00, for the Engineer, and**  
10 **declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for the removal and  
16 replacement of a heating/air conditioning five-zone unit system at the Engineer's main office  
17 facility; and

19 WHEREAS, a copy of the specifications are attached as Exhibit A; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
22 that is necessary and in the best interest of the County of Summit to authorize the Executive to  
23 advertise for bids for the aforementioned project;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

30 The County Executive is authorized to advertise for bids for the removal and replacement  
31 of a heating/air conditioning five-zone unit system at the Engineer's main office facility, for an  
32 estimated total cost not to exceed \$70,000.00.

36 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
37 of the citizens of the County of Summit, and for the further reason that it authorizes the  
38 Executive to immediately advertise for bids for the removal and replacement of the  
39 aforementioned heating/air conditioning unit in 2014.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.
