7 **A Resolution, subject to the approval of the Board of Control, authorizing the Executive to**
8 **execute a purchase contract with The Callos Companies to act as the employer of record**
9 **and provide payroll services for the 2014 Summer Youth Employment Program, for pass**
10 **through wages, FICA, Workers Compensation and administrative fees, for the period**
11 **5/15/14 through 9/30/14, in an amount not to exceed \$1,362,584.13, for the Executive's**
12 **Department of Job and Family Services, and declaring an emergency.**

14 WHEREAS, on April 14, 2014, Council approved the Executive's Department of Job and
15 Family Services to receive bids for payroll services for the Summer Youth Program; and

17 WHEREAS, the Executive's Department of Job and Family Services desires to award a
18 purchase contract with The Callos Companies to act as the employer of record and provide
19 payroll services for the 2014 Summer Youth Employment Program, for pass-through wages,
20 FICA, Workers Compensation and administrative fees, for the period 5/15/14 through 9/30/14;

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that the contract is necessary and in the best interest of the County of Summit to authorize the
25 Executive to execute said contract subject to the approval of the Board of Control;

32 The Executive is hereby authorized, subject to approval by the Board of Control, to
33 execute a purchase contract with The Callos Companies to act as the employer of record and
34 provide payroll services for the 2014 Summer Youth Employment Program, for pass through
35 wages, FICA, Workers Compensation and administrative fees, for the period 5/15/14 through
36 9/30/14, in an amount not to exceed \$1,362,584.13.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and
41 welfare of the citizens of the County of Summit, and for the further reason to immediately
42 provide for the payroll services effective 5/15/14.

47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
