14 service contract renewals (first of two) with providers per attached Exhibit A, for youth
15 employment and educational services, for the period 7/1/14 through 6/30/15, subject to
16 confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract renewals are necessary and in the best interest of the County of Summit;

26 The award by the Board of Control of professional service contract renewals (first of two)
27 with providers per attached Exhibit A, for youth employment and educational services, for the
28 period 7/1/14 through 6/30/15, in a total amount not to exceed \$580,000.00, is hereby confirmed
29 and the County Executive is hereby authorized to execute such contract renewals.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for youth employment and educational services effective 7/1/14.

40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.
