13 contract renewal (first of two) with Waste Management for trash removal at various facilities, for
14 the period 6/1/14 through 5/31/16; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that the purchase contract renewal is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

24 The award by the Board of Control of a purchase contract renewal (first of two) with
25 Waste Management for trash removal at various facilities, for the period 6/1/14 through 5/31/16,
26 in an amount not to exceed \$89,191.28, is hereby confirmed and the County Executive is hereby
27 authorized to execute such purchase contract renewal.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide for trash removal services effective 6/1/14.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
45 deliberations of this Council and of any of its committees that resulted in such formal action,
