7 **A Resolution authorizing the Executive to execute a collective bargaining agreement**  
8 **between the Summit County Sheriff's Supervisors' Association, the Sheriff and the**  
9 **Executive, for the period of 1/1/14 through 12/31/16, for the Executive and Sheriff, and**  
10 **declaring an emergency.**

12 WHEREAS, a tentative collective bargaining agreement has been reached between the  
13 Summit County Sheriff's Supervisor's Association, the Sheriff and the Executive, for the period  
14 1/1/14 through 12/31/16; and

16 WHEREAS, County Council finds and determines, after reviewing all pertinent  
17 information that the aforementioned collective bargaining agreement is in the best interest of the  
18 County and the Executive should be authorized to execute a collective bargaining agreement  
19 with the Summit County Sheriff's Supervisor's Association and the Sheriff for the period 1/1/14  
20 through 12/31/16;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
23 of Ohio, that:

25 SECTION 1

27 The County Executive is hereby authorized to execute a collective bargaining agreement  
28 between the Summit County Sheriff's Supervisor's Association, the Sheriff and the Executive,  
29 for the period 1/1/14 through 12/31/16.

31 SECTION 2

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the citizens of the County of Summit, and for the further reason to immediately  
35 providing a timely collective bargaining agreement between the parties.

37 SECTION 3

39 Provided this Resolution receives the affirmative vote of eight members, it shall take  
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
41 effect and be in force at the earliest time provided by law.

43 SECTION 4

45 It is found and determined that all formal actions of this Council concerning and relating  
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
47 deliberations of this Council and of any of its committees that resulted in such formal action,  
48 were in meetings open to the public, in compliance with all legal requirements, including Section  
49 121.22 of the Ohio Revised Code.


