7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Akron Canton Regional Food Bank to purchase food for distribution to food**  
9 **pantries throughout Summit County, for the period 6/1/14 through 9/30/14, in an amount**  
10 **not to exceed \$300,000.00, for the Executive's Department of Job and Family Services, and**  
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held May 28, 2014, awarded a  
14 professional service contract with Akron Canton Regional Food Bank to purchase food for  
15 distribution to food pantries throughout Summit County, for the period 6/1/14 through 9/30/14,  
16 subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

26 The award by the Board of Control of a professional service contract with Akron Canton  
27 Regional Food Bank to purchase food for distribution to food pantries throughout Summit  
28 County, for the period 6/1/14 through 9/30/14, in an amount not to exceed \$300,000.00, is  
29 hereby confirmed and the County Executive is hereby authorized to execute such contract.

31 SECTION 2

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the citizens of the County of Summit, and for the further reason to immediately  
35 provide for food purchases for distribution to food pantries throughout Summit County effective  
36 6/1/14.

38 SECTION 3

40 Provided this Resolution receives the affirmative vote of eight members, it shall take  
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating  
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
48 deliberations of this Council and of any of its committees that resulted in such formal action,  
49 were in meetings open to the public, in compliance with all legal requirements, including Section  
50 121.22 of the Ohio Revised Code.


