7 **A Resolution confirming an award by the Board of Control of a purchase order with**
8 **Central Flooring and Acoustics, Inc., to furnish and install new carpet on the fifth floor of**
9 **the Ohio Building, under State Term Pricing, in Council District 4, in an amount not to**
10 **exceed \$49,402.99, for the Executive's Department of Administrative Services – Physical**
11 **Plants, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held May 21, 2014, awarded a purchase
14 order with Central Flooring and Acoustics, Inc., to furnish and install new carpet on the fifth
15 floor of the Ohio Building, under State Term Pricing, in Council District 4, subject to
16 confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the purchase order is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a purchase order with Central Flooring and
27 Acoustics, Inc., to furnish and install new carpet on the fifth floor of the Ohio Building, under
28 State Term Pricing, in Council District 4, in an amount not to exceed \$49,402.99, is hereby
29 confirmed and the County Executive is hereby authorized to execute such purchase order.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 replace worn carpet in 2014.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,
