7 **A Resolution confirming an award by the Board of Control of a lease of office space with**
8 **the City of Akron for the Summit County Drug Unit, for the period 2/1/14 through 1/31/15,**
9 **in the amount of \$3,500.00 per month, for a total amount of \$42,000.00, for the Sheriff, and**
10 **declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held May 28, 2014, awarded a lease of
13 office space with the City of Akron for the Summit County Drug Unit, for the period 2/1/14
14 through 1/31/15, subject to confirmation by County Council; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that the lease is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

24 The award by the Board of Control of a lease of office space with the City of Akron for
25 the Summit County Drug Unit, for the period 2/1/14 through 1/31/15, in the amount of \$3,500.00
26 per month, for a total amount of \$42,000.00, is hereby confirmed and the County Executive is
27 hereby authorized to execute such lease.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide for the Drug Unit office space lease in 2014.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
45 deliberations of this Council and of any of its committees that resulted in such formal action,
