7 **A Resolution authorizing the County Executive to advertise for bids for the construction of**
8 **the S.A.M. Campus Sanitary Sewer Project Q-450, in Council District 3, for an estimated**
9 **total cost not to exceed \$1,913,652.00, for the Executive's Department of Environmental**
10 **Services, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

14
15 WHEREAS, S.A.M. Campus Sanitary Sewer Project Q-450 was previously advertised
16 for bids under the authority of Resolution No. 2014-114, but no bids were received under 10%
17 greater than the engineer's estimate of cost; and

18
19 WHEREAS, a revised engineer's estimate of cost has been prepared in an amount not to
20 exceed \$1,913,652.00; and

21
22 WHEREAS, the County Executive wishes to advertise for bids for the construction of the
23 S.A.M. Campus Sanitary Sewer Project Q-450, in Council District 3 in accordance with the
24 revised engineer's estimate; and

26 WHEREAS, a copy of the specifications are on file with the Clerk of Council; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that is necessary and in the best interest of the County of Summit to authorize the Executive to
30 advertise for bids for the aforementioned project;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that;

37 The County Executive is authorized to advertise for bids for the construction of the
38 S.A.M. Campus Sanitary Sewer Project Q-450, in Council District 3, for an estimated total cost
39 not to exceed \$1,913,652.00.

43 This Resolution is declared an emergency in the interest of the health, safety, and welfare
44 of the citizens of the County of Summit, and for the further reason that it authorizes the
45 Executive to immediately advertise for bids for the construction of the S.A.M. Campus Sanitary
46 Sewer Project Q-450, in Council District 3, in 2014.

51 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
