7 **A Resolution confirming an award by the Board of Control of a construction contract with**
8 **Jennings Heating Company, Inc., for the installation of a new heating/air conditioning five-**
9 **zone system with optional wireless remote access and system alerts, in an amount not to**
10 **exceed \$84,775.00, for the Engineer, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held June 18, 2014, awarded a
13 construction contract with Jennings Heating Company, Inc., for the installation of a new
14 heating/air conditioning five-zone system with optional wireless remote access and system alerts,
15 subject to confirmation by County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the contract is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

25 The award by the Board of Control of a construction contract with Jennings Heating
26 Company, Inc., for the installation of a new heating/air conditioning five-zone system with
27 optional wireless remote access and system alerts, in an amount not to exceed \$84,775.00, is
28 hereby confirmed and the County Executive is hereby authorized to execute such contract.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide for the installation of the heating/air conditioning system in 2014.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,

48 121.22 of the Ohio Revised Code.
