7 **A Resolution, pursuant to Section 177.13 of the Codified Ordinances of the County of**
8 **Summit, ratifying purchases by the Sheriff in calendar year 2014 from Northland IT**
9 **Solutions, Inc., for the maintenance of the jail management system software, for a total**
10 **aggregate amount not to exceed \$35,000.00, for calendar year 2014, for the Sheriff, and**
11 **declaring an emergency.**

13 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit
14 requires that purchases by an officeholder exceeding \$25,000.00 in aggregate in any calendar
15 year, where no additional competitive quotes or bids have been taken, shall be made only upon
16 authorization of County Council; and

18 WHEREAS, the Board of Control has previously approved purchases by the Sheriff in
19 calendar year 2014 from Northland IT Solutions, Inc., for the maintenance of the jail
20 management system software totaling \$24,990.00, and the Sheriff expects to spend an additional
21 \$10,010.00 in 2014, for a total not to exceed \$35,000.00; and

23 WHEREAS this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County to ratify purchases by the Sheriff in
25 calendar year 2014 from Northland IT Solutions, Inc., for the maintenance of the jail
26 management system software, for a total aggregate amount not to exceed \$35,000.00;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that:

33 This Council hereby ratifies purchases by the Sheriff in calendar year 2014 from
34 Northland IT Solutions, Inc., for the maintenance of the jail management system software, for a
35 total aggregate amount not to exceed \$35,000.00.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and
40 welfare of the citizens of the County of Summit, and for the further reason to immediately ratify
41 purchases already made by the Sheriff to ensure compliance with Section 177.13 of the Codified
42 Ordinances of the County of Summit.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.
