15 WHEREAS, the County Executive wishes to advertise for bids for the construction of the
16 Adaline and Lakeview Drives Sewer Lining Project Q-448, in Council District 3, for an
17 estimated total cost not to exceed \$330,000.00; and

23 that is necessary and in the best interest of the County of Summit to authorize the Executive to
