7 **A Resolution confirming an award by the Board of Control for the renewal (second of two)**
8 **of various professional service contracts for Temporary Assistance for Needy Families**
9 **supportive service contracts, per attached Exhibit A, for Federal Fiscal Year 2015, for the**
10 **period 10/1/14 through 9/30/15, in a total amount not to exceed \$425,800.00, for the**
11 **Executive's Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held July 30, 2014, awarded the renewal
14 (second of two) of various professional service contracts for Temporary Assistance for Needy
15 Families supportive service contracts, per attached Exhibit A, for Federal Fiscal Year 2015, for
16 the period 10/1/14 through 9/30/15, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract renewals are necessary and in the best interest of the County of Summit;

26 The award by the Board of Control for the renewal (second of two) of various
27 professional service contracts for Temporary Assistance for Needy Families supportive service
28 contracts, per attached Exhibit A, for Federal Fiscal Year 2015, for the period 10/1/14 through
29 9/30/15, in a total amount not to exceed \$425,800.00, is hereby confirmed and the County
30 Executive is hereby authorized to execute such renewals.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide for the contract services effective 10/1/14.

41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.
