7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Asian Services in Action, Inc., for onsite employment services for refugee**

12 WHEREAS, the Board of Control, at its meeting held July 30, 2014, awarded a
13 professional service contract with Asian Services in Action, Inc., for refugee employment
14 services, for the period 10/1/14 through 9/30/15, subject to confirmation by County Council; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that the contract is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

24 The award by the Board of Control of a professional service contract with Asian Services
25 in Action, Inc., for onsite employment services for refugee clients, for the period 10/1/14 through
26 9/30/15, in an amount not to exceed \$41,400.00, is hereby confirmed and the County Executive
27 is hereby authorized to execute such contract.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide for onsite employment services for refugee clients effective 10/1/14.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
