15 WHEREAS, the County Executive wishes to advertise for bids for Pump Station No. 6
16 Sewer Force Main Replacement Phase 3 Project Q-325-3, in Council District 3, and

18 WHEREAS, a copy of the plans and specifications are on file with the Clerk of Council;

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that is necessary and in the best interest of the County of Summit to authorize the Executive to

38 of the citizens of the County of Summit, and for the further reason that it authorizes the


