7 **A Resolution amending Resolution No. 2014-287 to authorize the County Executive to**
8 **advertise for bids for the purchase of one trailer for hauling of wastewater sludge for an**
9 **estimated total cost not to exceed \$65,000.00, for the Executive's Department of**
10 **Environmental Services, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

14
15 WHEREAS, County Council previously adopted Resolution No. 2014-287, which
16 authorized the County Executive to advertise for bids for the purchase of two trailers for hauling
17 of wastewater sludge for an estimated total cost not to exceed \$65,000.00; and

18
19 WHEREAS, Executive's Department of Environmental Services ("DOES") should have
20 requested this Council to authorize the County Executive to advertise for bids for the purchase of
21 only one trailer for hauling of wastewater sludge for an estimated total cost not to exceed
22 \$65,000.00 in Resolution No. 2014-287, but requested authority to bid for two in error; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to amend Resolution No.
26 2014-287 to accurately reflect authorization for the County Executive to advertise for bids for the
27 purchase of only one trailer for hauling of wastewater sludge for an estimated total cost not to
28 exceed \$65,000.00; and

30 WHEREAS, a copy of the technical specifications are attached as Exhibit A;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that;

37 Section 1 of Resolution No. 2014-287 is hereby amended to authorize the County
38 Executive to advertise for bids for the purchase of one trailer for hauling of wastewater sludge
39 for an estimated total cost not to exceed \$65,000.00.

44 of the citizens of the County of Summit, and for the further reason that it authorizes the
