7 **A Resolution authorizing the County Executive to execute a lease agreement with the City**
8 **of Barberton, Village of Clinton and City of New Franklin, for a P25 radio system, with**
9 **towers located at 303 East Tuscarawas Avenue in Barberton and 6639 Grove Road in**
10 **Clinton, for the period 10/1/14 through 12/31/24, at no cost, for the Executive's Department**
11 **of Law, Insurance and Risk Management – Division of Public Safety, and declaring an**
12 **emergency.**

13
14 WHEREAS, the County of Summit and City of Akron operate and maintain the Summit
15 County-Akron 800 MHz Regional Radio System ("SCA8RRS") for public safety agencies in
16 Summit County, of which the City of Barberton, Village of Clinton and City of New Franklin
17 are users; and

18
19 WHEREAS, these communities collectively purchased a P25 radio system with funds
20 from the Fiscal Year 2011 Assistance to Firefighters Grant Program provided by the Federal
21 Emergency Management Agency and the U.S. Department of Homeland Security and affixed the
22 system to the radio towers located at 303 East Tuscarawas Avenue in Barberton and 6639 Grove
23 Road in Clinton; and

25 WHEREAS, these communities desire to lease the aforementioned system, at no cost, for
26 the period 10/1/14 through 12/31/24, to the County of Summit and City of Akron, to increase
27 interoperability and for use with the SCA8RRS; and

29 WHEREAS, the operational and maintenance costs shall be paid for through SCA8RRS
30 user fees; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
33 that the aforementioned lease agreement is necessary and in the best interest of the County of
34 Summit;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
37 of Ohio, that:

39 SECTION 1

41 The County Executive is hereby authorized to enter into a lease agreement with the City
42 of Barberton, Village of Clinton and City of New Franklin for a P25 radio system, with towers
43 located at 303 East Tuscarawas Avenue in Barberton and 6639 Grove Road in Clinton, for the
44 period 10/1/14 through 12/31/24, at no cost.

46 SECTION 2

48 This Resolution is declared an emergency in the interest of the health, safety and welfare
49 of the citizens of the County of Summit and for the further purpose to immediately provide a
50 necessary lease agreement for the integration of the Barberton, Clinton, New Franklin P25 radio
51 system into the SCA8RRS which serves public safety entities throughout Summit County.
