7 **A Resolution confirming an award by the Board of Control of an intergovernmental**
8 **agreement with the County of Summit Sheriff for a IV-D contract to provide**
9 **reimbursement for extradition services, for the period 10/1/14 through 9/30/15, in an**
10 **amount not to exceed \$64,595.00, for the Prosecutor's Child Support Enforcement Agency,**
11 **and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held August 6, 2014, awarded an
14 intergovernmental agreement with the County of Summit Sheriff for a IV-D contract to provide
15 reimbursement for extradition services, for the period 10/1/14 through 9/30/15, subject to
16 confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of an intergovernmental agreement with the County
27 of Summit Sheriff for a IV-D contract to provide reimbursement for extradition services, for the
28 period 10/1/14 through 9/30/15, in an amount not to exceed \$64,595.00, is hereby confirmed and
29 the County Executive is hereby authorized to execute such contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for extradition services effective 10/1/14.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,
