7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award of a Selective Traffic Enforcement Program grant from the Ohio**
9 **Department of Public Safety, for the period 10/1/14 through 9/30/15, in the amount of**
10 **\$33,146.36, with no local cash match requirement, and appropriating grant funds, for the**
11 **period 10/1/14 through 12/31/14, for the Sheriff, and declaring an emergency.**

13 WHEREAS, County of Summit Sheriff's Office has been awarded \$33,146.36, with no
14 local cash match requirement, from the Ohio Department of Public Safety ("ODPS"), through
15 their Ohio Traffic Safety Office ("OTSO"), in order to operate a STEP program in the County of
16 Summit; and

18 WHEREAS, the STEP grant has provided funding for the past 15 years to the Sheriff's
19 Office for work overtime, in order to conduct selective traffic enforcement, public awareness and
20 education in the County of Summit; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that authorizing the County Executive to execute any documents necessary to accept the
24 aforementioned grant, and the appropriations of the aforementioned grant funds, is necessary and
25 in the best interest of the County of Summit;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that:

32 The County Executive is hereby authorized to execute any documents necessary to accept
33 a grant award from the Ohio Department of Public Safety for a Selective Traffic Enforcement
34 Program ("STEP") Overtime grant, for the period 10/1/14 through 9/30/15, in the amount of
35 \$33,146.36, with no local cash match requirement.
