7 **A Resolution authorizing the County Executive to advertise for bids for the construction of**
8 **the Pump Station 13 Sewer Force Main Replacement Project Q-451, in Council District 3,**
9 **for an estimated total cost not to exceed \$442,000.00, for the Executive's Department of**
10 **Environmental Services, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for the construction of the
16 Pump Station 13 Sewer Force Main Replacement Project Q-451, in Council District 3, and

18 WHEREAS, a copy of the plans and specifications are on file with the Clerk of Council;

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that is necessary and in the best interest of the County of Summit to authorize the Executive to
23 advertise for bids for the construction of the Pump Station 13 Sewer Force Main Replacement
24 Project Q-451, in Council District 3;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that;

31 The County Executive is authorized to advertise for bids for the construction of the Pump
32 Station 13 Sewer Force Main Replacement Project Q-451, in Council District 3, for an estimated
33 total cost not to exceed \$442,000.00.

37 This Resolution is declared an emergency in the interest of the health, safety, and welfare
38 of the citizens of the County of Summit, and for the further reason that it authorizes the
39 Executive to immediately advertise for bids for the construction of the Pump Station 13 Sewer
40 Force Main Replacement Project Q-451, in Council District 3.

45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
