7 **A Resolution authorizing the County Executive to disburse funds exceeding an aggregate**
8 **\$25,000.00 for calendar year 2014 and to execute any documents necessary to extend its**
9 **agreement with Greenleaf Family Center, to assist two-parent households in meeting**
10 **mandated Ohio Works First work participation requirements, for the period 10/1/14**
11 **through 12/31/14, in the amount of \$14,400.00, for the Executive's Department of Job and**
12 **Family Services, and declaring an emergency.**

14 WHEREAS, Section 177.21 of the Codified Ordinances of the County of Summit
15 requires the approval of County Council for all contracts with a vendor exceeding \$25,000.00 in
16 the aggregate in any calendar year which are funded by State of Ohio or federal pass-through
17 dollars for which the County has no discretion in selecting the vendor; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
21 disburse funds exceeding an aggregate \$25,000.00 for calendar year 2014 and to execute any
22 documents necessary to extend its agreement with Greenleaf Family Center, to assist two-parent
23 households in meeting mandated Ohio Works First work participation requirements, for the
24 period 10/1/14 through 12/31/14;

26 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
27 State of Ohio, that:

29 SECTION 1

31 The County Executive is hereby authorized to disburse funds exceeding an aggregate
32 \$25,000.00 for calendar year 2014 and to execute any documents necessary to extend its
33 agreement with Greenleaf Family Center, to assist two-parent households in meeting mandated
34 Ohio Works First work participation requirements, for the period 10/1/14 through 12/31/14, in
35 the amount of \$14,400.00.

37 SECTION 2

39 This Resolution is hereby declared to be an emergency in the interest of the health, safety
40 and welfare of the citizens of the County of Summit and for the further reason that it is necessary
41 to immediately authorize the extension of the agreement in 2014.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take
46 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect
47 and be in force at the earliest time provided by law.
