7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Greenleaf Family Center to provide Supporting Partnerships to Assure**  
9 **Ready Kids services, for the period 10/1/14 through 9/30/15, in an amount not to exceed**  
10 **\$55,000.00, for the Executive's Department of Job and Family Services, and declaring an**  
11 **emergency.**

13 WHEREAS, the Board of Control, at its meeting held September 3, 2014, awarded a  
14 professional service contract with Greenleaf Family Center to provide Supporting Partnerships to  
15 Assure Ready Kids services, for the period 10/1/14 through 9/30/15, subject to confirmation by  
16 County Council; and,

18 WHEREAS, County Council has determined by reviewing all pertinent information that  
19 the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a professional service contract with Greenleaf  
27 Family Center to provide Supporting Partnerships to Assure Ready Kids services, for the period  
28 10/1/14 through 9/30/15, in an amount not to exceed \$55,000.00, is hereby confirmed and the  
29 County Executive is hereby authorized to execute such contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the citizens of the County of Summit, and for the further reason to provide Supporting  
35 Partnerships to Assure Ready Kids services effective 10/1/14.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take  
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
41 effect and be in force at the earliest time provided by law.

46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
47 deliberations of this Council and of any of its committees that resulted in such formal action,
