7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept the award of federal funds from the State of Ohio Attorney General’s Office of a**  
9 **Federal Fiscal Year 2014 Victims of Crime Act training grant in the amount of \$1,500.00,**  
10 **with no local cash match requirement, for the period 10/1/13 through 9/30/14, and**  
11 **appropriating \$1,500.00 for expenditures through 12/31/14, for the County of Summit**  
12 **Court of Common Pleas – Juvenile Division, and declaring an emergency.**

14 WHEREAS, the County of Summit Court of Common Pleas – Juvenile Division has  
15 received an award from the State of Ohio Attorney General’s Office of a Federal Fiscal Year  
16 (“FFY”) 2014 Victims of Crime Act (“VOCA”) grant in the amount of \$1,500.00, for the period  
17 10/1/13 through 9/30/14; and

19 WHEREAS, the grant is to allow a juvenile court employee to attend the 2014 National  
20 Organization for Victims Assistance (“NOVA”) conference in Chicago, Illinois; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
23 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
24 execute any documents necessary to accept the award of the aforementioned grant from the State  
25 of Ohio Attorney General’s Office, and to appropriate these grant funds;
