7 **A Resolution moving the non-bargaining classified position of Chief Investigator #40086 in**
8 **the County Prosecutor's Office from the classified service to the unclassified service, for the**
9 **Human Resource Commission and the Executive's Department of Human Resources, and**
10 **declaring an emergency.**

12 WHEREAS, County Council has the authority pursuant to Article III, Section 3.03 (10)
13 of the Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the
14 Codified Ordinances of the County of Summit to establish classifications, classification
15 specifications and pay/salary schedules for all County employees; and

16
17 WHEREAS, the County Prosecutor has requested pursuant to Section 169.11 of the
18 Codified Ordinances that the non-bargaining classified position of Chief Investigator #40086 be
19 moved from the classified service to the unclassified service because the position has a fiduciary
20 responsibility to the Prosecutor; and

22 WHEREAS, the Human Resource Commission, at its August 7, 2014 meeting, approved
23 moving the non-bargaining classified position of Chief Investigator #40086 in the Prosecutor's
24 Office from the classified service to the unclassified service, as set forth in HRC Order No. 14-
25 10, attached to this Resolution as Exhibit A; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County of Summit to move the non-bargaining
29 classified position of Chief Investigator #40086 in the Prosecutor's Office from the classified
30 service to the unclassified service;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The following non-bargaining classification is hereby moved from the classified service
38 to the unclassified service. The classification specification and salary schedule for this
39 classification previously approved by County Council, attached hereto as Exhibits B and C, shall
40 remain the same.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the citizens and employees of the County of Summit, and for the further reason that it
48 is necessary in order to immediately move the non-bargaining classified position of Chief
49 Investigator #40086 in the County Prosecutor's Office from the classified service to the
50 unclassified service.
