7 **A Resolution approving the classification, classification specification and salary schedule**
8 **for the non-bargaining classified position of Assessment Coordinator #34061 at the County**
9 **Executive's Department of Environmental Services, and adding said position to the**
10 **County's 2014 Staffing Report, for the Human Resource Commission and the Executive's**
11 **Department of Human Resources, and declaring an emergency.**

13 WHEREAS, County Council has the authority pursuant to Article III, Section 3.03 (10)
14 of the Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the
15 Codified Ordinances of the County of Summit to establish classifications, classification
16 specifications and pay/salary schedules for all County employees; and

18 WHEREAS, the County Executive has requested pursuant to Section 169.11 that the
19 Human Resource Commission ("HRC") approve the classification, classification specification
20 and salary schedule for the non-bargaining classified position of Assessment Coordinator #34061
21 at the Executive's Department of Environmental Services ("DOES"); and

23 WHEREAS, the Human Resource Commission, at its August 7, 2014 meeting, approved
24 the position of Assessment Coordinator #34061 at DOES, as set forth in HRC Order No. 14-09,
25 attached to this Resolution as Exhibit A; and

27 WHEREAS, it is necessary to add the position to the County's 2014 Staffing Report,
28 attached as Exhibit A to Amended Resolution No. 2013-494 previously adopted by this Council;

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
32 that it is necessary and in the best interest of the County of Summit to approve the classification,
33 classification specification and salary schedule for the non-bargaining classified position of
34 Assessment Coordinator #34061 at DOES and to add the position to the County's 2014 Staffing
35 Report;
