13 WHEREAS, this Council previously adopted Resolution No. 2013-390 authorizing the
14 County of Summit to be named as fiscal agent for a Fiscal Year 2000 Metropolitan Medical
15 Response System ("MMRS") grant, in the amount of \$280,739.00, with no local cash match
16 requirement; and

18 WHEREAS, it is necessary to appropriate the aforementioned funds to further the goal of
19 the MMRS program of enhancing local health and medical response to victims of terrorist
20 incidents and other public health emergencies; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that it is necessary and in the best interest of the County of Summit to appropriate the
24 aforementioned funds in the amount of \$280,739.00;
