7 **A Resolution authorizing the County Executive to execute a three-year policing contract**  
8 **with Twinsburg Township, in Council District 1, pursuant to which the County Sheriff will**  
9 **provide Twinsburg Township with 12,095.20 Sheriff's Deputy hours for the period 1/1/15**  
10 **through 12/31/17, in exchange for payment by Twinsburg Township of the amount of**  
11 **\$897,293.45 for the first year, \$918,138.92 for the second year and \$938,393.46 for the third**  
12 **year, for a total amount of \$2,753,825.83 during the three-year term of the contract, for the**  
13 **Sheriff, and declaring an emergency.**

14  
15 WHEREAS, County Council previously adopted Resolution No. 2011-423, which  
16 authorized the County Executive to execute a three-year policing contract with Twinsburg  
17 Township, in Council District 1, pursuant to which the County Sheriff provided seven Sheriff's  
18 Deputies to Twinsburg Township for the period 1/1/12 through 12/31/14, in exchange for  
19 payment by Twinsburg Township of the amount of \$743,149.33 for the first year, \$751,696.67  
20 for the second year and \$756,212.00 for the third year, in a total amount of \$2,251,058.00 during  
21 the three-year term of the contract; and

23 WHEREAS, Twinsburg Township has requested that the County of Summit enter into a  
24 new contract pursuant to which the Sheriff will provide Twinsburg Township with 12,095.20  
25 deputy hours for the period 1/1/15 through 12/31/17; and

27 WHEREAS, Twinsburg Township has agreed to pay the County \$897,293.45 for the first  
28 year, \$918,138.92 for the second year and \$938,393.46 for the third year, for a total amount of  
29 \$2,753,825.83 during the three-year term of the contract; and

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
32 that authorizing the Executive to execute the aforementioned contract is necessary and in the best  
33 interest of the County of Summit;

35 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
36 of Ohio, that;

40 The County Executive is hereby authorized to execute a three-year policing contract with  
41 Twinsburg Township, in Council District 1, pursuant to which the County Sheriff will provide  
42 Twinsburg Township with 12,095.20 Sheriff's Deputy hours for the period of 1/1/15 through  
43 12/31/17, in exchange for payment by Twinsburg Township in the amount of \$897,293.45 for  
44 the first year, \$918,138.92 for the second year and \$938,393.46 for the third year, for a total  
45 amount of \$2,753,825.83 during the three-year term of the contract.

49 This Resolution is hereby declared an emergency in the interest of the health, safety and  
50 welfare of the citizens of the County of Summit and for the further purpose of immediately  
51 providing necessary policing for Twinsburg Township, in Council District 1, effective 1/1/15.
