7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award from the Ohio Department of Job and Family Services of federal funds in**
9 **the form of a State Fiscal Year 2015 Connecting the Dots Temporary Assistance for Needy**
10 **Families Demo grant, for the period 10/1/14 through 9/30/15, in the amount of \$218,000.00,**
11 **with no local cash match requirement, and appropriating the total grant award for**
12 **expenditures in calendar year 2014, for the Executive’s Department of Job and Family**
13 **Services, and declaring an emergency.**

15 WHEREAS, the County Executive’s Department of Job and Family Services
16 (“SCDJFS”) has received notification of a pending award from the Ohio Department of Job and
17 Family Services (“ODJFS”) of federal funds in the form of a State Fiscal Year 2015 (“SFY
18 2015”) Connecting the Dots Temporary Assistance for Needy Families (“TANF”) Demo grant,
19 in the amount of \$218,000.00, with no local cash match requirement; and

21 WHEREAS, these funds will enable SCDJFS to operate a Connecting the Dots program
22 within SFY 2015, for the period 10/1/14 through 9/30/15, with the purpose of improving the
23 educational and employment outcomes for Summit County youth aging out of foster care and
24 supporting their transition to adulthood; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
28 execute any documents necessary to accept the award from ODJFS of federal funds in the form
29 of the aforementioned TANF Demo grant and to appropriate the total grant award;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that:

36 The County Executive is hereby authorized to execute any documents necessary to accept
37 the award from the Ohio Department of Job and Family Services (“ODJFS”) of federal funds in
38 the form of a State Fiscal Year 2015 (“SFY 2015”) Connecting the Dots Temporary Assistance
39 for Needy Families (“TANF”) Demo grant, for the period 10/1/14 through 9/30/15, in the
40 amount of \$218,000.00, with no local cash match requirement.
