7 **A Resolution confirming an award by the Board of Control of a construction contract with**  
8 **RBS General Contracting, LLC, for storm sewer improvements to Treecrest Drive, in**  
9 **Council District 4, in an amount not to exceed \$188,524.40, and appropriating funds in the**  
10 **amount of \$188,524.40, for the Engineer, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held November 5, 2014, awarded a  
13 construction contract with RBS General Contracting, LLC, for storm sewer improvements to  
14 Treecrest Drive, in Council District 4, subject to confirmation by County Council; and

16 WHEREAS, Council previously approved Resolution No. 2014-280 granting Bath  
17 Township's Treecrest Drive ditch petition, in accordance with Section 6131.21 of the Ohio  
18 Revised Code, for the Council and declaring an emergency;

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
21 that the contract is necessary and in the best interest of the County of Summit;
