7 **A Resolution confirming an award by the Board of Control of a construction contract with**
8 **United Survey, Inc., for the Adaline and Lakeview Sanitary Sewer Lining Project Q-448, in**
9 **Council District 3, in an amount not to exceed \$204,639.50, and appropriating funds in an**
10 **amount not to exceed \$204,639.50 for the period ending 12/31/14, for the Executive's**
11 **Department of Environmental Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held October 29, 2014, awarded a
14 construction contract with United Survey, Inc., for the Adaline and Lakeview Sanitary Sewer
15 Lining Project Q-448, in Council District 3, subject to confirmation by County Council; and

17 WHEREAS, it is necessary to appropriate funds to pay for said contract out of the Sewer
18 Enterprise Fund; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the contract is necessary and in the best interest of the County of Summit;

28 The award by the Board of Control of a construction contract with United Survey, Inc.,
