7 **A Resolution confirming an award by the Board of Control of an intergovernmental**
8 **agreement with the County of Summit Sheriff for its IV-D provider contract for**
9 **reimbursement of security services, for the period 1/1/15 through 12/31/15, in an amount**
10 **not to exceed \$183,300.39, for the Prosecutor's Child Support Enforcement Agency, and**
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held November 5, 2014, awarded an
14 intergovernmental agreement with the County of Summit Sheriff for its IV-D provider contract
15 for reimbursement of security services, for the period 1/1/15 through 12/31/15, subject to
16 confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the agreement is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of an intergovernmental agreement with the County
27 of Summit Sheriff for its IV-D provider contract for reimbursement of security services, for the
28 period 1/1/15 through 12/31/15, in an amount not to exceed \$183,300.39, is hereby confirmed
29 and the County Executive is hereby authorized to execute such agreement.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for the reimbursement of security services effective 1/1/15.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.




