11 WHEREAS, the Executive's Department of Law, Insurance and Risk Management -
12 Division of Public Safety, received a State Fiscal Year 2015 Safe Communities grant from the
13 Ohio Department of Public Safety's Traffic Safety Office, in the amount of \$79,585.23; and

15 WHEREAS, pursuant to Resolution No. 2014-392, this Council originally authorized the
16 County Executive to accept and appropriate the aforementioned grant; and

18 WHEREAS, programmatic changes within the grant require appropriation adjustments
19 for a portion of these funds, in the amount of \$55,456.00; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that it is necessary and in the best interest of the County of Summit to adjust appropriations for
23 the aforementioned grant fund in the amount of \$55,456.00;
