7 **A Resolution increasing appropriations in the amount of \$520.01 to reflect an amended**
8 **federal Temporary Assistance to Needy Families Summer Youth Employment Program**
9 **grant from the Executive's Department of Job and Family Services, and adjusting existing**
10 **appropriations in the amount of \$2,257.74 for the Youth Employment for Success 2014**
11 **Summer Youth Employment Program, for the Executive's Department of**
12 **Communications, and declaring an emergency.**

14 WHEREAS, this Council previously adopted Resolutions No's. 2014-168 and 2014-209
15 confirming an award from Executive's Department of Job and Family Services ("DJFS") of
16 Temporary Assistance to Needy Families ("TANF") funds from the Ohio Department of Job and
17 Family Services, which have been appropriated for a Summer Youth Employment Program; and

19 WHEREAS, DJFS has awarded an additional \$520.01 of the TANF funds to the
20 Executive's Department of Communications Youth Employment for Success ("YES") 2014
21 Summer Youth Employment Program; and

23 WHEREAS, an adjustment is needed in the amount of \$2,257.74 for the YES 2014
24 Summer Youth Employment Program; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that authorizing the Executive to execute any documents necessary to accept and appropriate the
28 aforementioned grant funds is necessary and in the best interest of the County of Summit;
