7 **A Resolution approving a boundary line change between the City of Stow and the City of**
8 **Munroe Falls, in Council Districts 2 and 3, for the Executive, and declaring an emergency.**

10 WHEREAS, Section 709.37 of the Ohio Revised Code provides that any two adjoining
11 municipal corporations may by ordinance agree to a change in the boundary line separating
12 them, provided that the change does not involve the transfer of territory inhabited by more than
13 five voters; and

14
15 WHEREAS, Section 709.37 requires the municipalities agreeing to a boundary line
16 change shall certify the ordinances approving the change to the county for approval; and

17
18 WHEREAS, Section 709.37 further requires that upon receipt of certified copies of said
19 ordinances, a county shall approve the boundary line change; and

20
21 WHEREAS, the City of Stow and the City of Munroe Falls have agreed to a change in
22 their boundary line in accordance with the diagram attached hereto as Exhibit A and incorporated
23 herein as if fully restated, in Council Districts 2 and 3; and

25 WHEREAS, the City of Stow and the City of Munroe Falls have certified ordinances
26 approving the aforementioned boundary line change to the County of Summit, which are
27 attached hereto as Exhibits B and C and incorporated herein as if fully restated; and

29 WHEREAS, this Council has determined by reviewing all pertinent information that it is
30 necessary and in the best interest of the County of Summit to approve the boundary line change
31 agreed to by the City of Stow and the City of Munroe Falls;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that:

36 SECTION 1

38 The County of Summit hereby approves the adjustment of the boundary between the City
39 of Stow and the City of Munroe Falls in accordance with the diagram attached hereto as Exhibit
40 A and incorporated herein as if fully restated, in Council Districts 2 and 3.

42 SECTION 2

44 The City of Stow and the City of Munroe Falls shall pay all fees and costs of recording
45 transcripts of the ordinances, any agreements and this Resolution with the Recorder Division of
46 the County Fiscal Officer, as required by Section 709.37 of the Ohio Revised Code.

50 This Resolution is declared an emergency in the interest of the health, safety and welfare
51 of the citizens of the County of Summit and for the further reason to immediately approve a
52 boundary line change between the City of Stow and the City of Munroe Falls.
