7 **An Substitute Ordinance amending Chapter 923 of the Codified Ordinances of the County**  
8 **of Summit, entitled “Fees and User Charge System”, to extend the current 2014 sewer**  
9 **charges, surcharges and fees into the first quarter of calendar year 2015, for the**  
10 **Executive’s Department of Environmental Services, and declaring an emergency.**

11  
12 WHEREAS, in Ordinance No. 2006-550, the County Council amended certain sections  
13 of Chapter 923 of the Codified Ordinances of the County of Summit, entitled “Fees and User  
14 Charge System”, and set the various user charges, surcharges and fees for the Summit County  
15 Metropolitan Sewer District, administered by the Executive’s Department of Environmental  
16 Services.

17  
18 WHEREAS, the current Chapter 923 contains user charges, surcharges and fees for  
19 calendar year 2014;

20  
21 WHEREAS, it is necessary to set all user charges, surcharges and fees in Chapter 923 for  
22 the first quarter of calendar year 2015; and

23  
24 WHEREAS, this Council has determined by reviewing all pertinent information that the  
25 user charges, surcharges and fees contained in Chapter 923 of the Codified Ordinances of the  
26 County of Summit should remain at the same rates and amounts in the first quarter of calendar  
27 year 2015 as they are for the current year 2014; and

29 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
30 necessary to amend Sections 923.01, 923.02, 923.03, 923.05, 923.06, 923.07 and 923.08 of the  
31 Codified Ordinances of the County of Summit to implement said extension of the user charges,  
32 surcharges and fees; and

34 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State of  
35 Ohio, that:

39 Sections 923.01, 923.02, 923.03, 923.05, 923.06, 923.07 and 923.08 of the Codified  
40 Ordinances of the County of Summit are hereby amended as shown on Substitute Exhibit A,  
41 attached hereto and incorporated herein as if fully restated.

45 This Ordinance is hereby declared an emergency in the interest of the health, safety and  
46 welfare of the citizens of the County of Summit, and for the further reason of immediately  
47 amending Sections 923.01, 923.02, 923.03, 923.05, 923.06, 923.07 and 923.08 of the Codified  
48 Ordinances of the County of Summit, in order to immediately implement the user charges,  
49 surcharges and fees for the Summit County Metropolitan Sewer District for the first quarter of  
50 calendar year 2015.

7 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
8 effect and be in force at the earliest time provided by law.

16 121.22 of the Ohio Revised Code.
