7 **A Resolution authorizing the County Executive to execute an Agreement of Cooperation**
8 **with Medina County for the joint improvement of Medina Line Road, located in Copley**
9 **Township and the City of Norton, Council Districts 5 and 7, in an estimated amount of**
10 **\$145,260.00, for the Engineer, and declaring an emergency.**

12 WHEREAS, the County Engineer finds a public need for the improvement of Medina
13 Line Road, from Greenwich Road to Ridgewood Road, located in Copley Township and the City
14 of Norton, Council Districts 5 and 7 ("Project"); and

15
16 WHEREAS, the Project's estimated cost including engineering, construction,
17 construction engineering and inspection ("Project's Cost") is \$2,690,000.00; and

18
19 WHEREAS, the Medina County Engineer will apply federal funds for the Project,
20 through the Metropolitan Planning Organization, Northeast Ohio Area Coordinating Agency,
21 under which they will provide 80% of the Project Cost; and

22
23 WHEREAS, the County of Summit will provide its portion of the local share, in an
24 amount estimated at \$145,260.00; and

25
26 WHEREAS, the Summit County Engineer and Medina County Engineer desire to enter
27 into an agreement of cooperation to confirm the Project's cost and to designate Medina County
28 as the lead agency for administration of design engineering, competitive bidding, construction
29 and construction engineering of the Project; and

31 WHEREAS, Sections 5501.03(c) and 5543.01 of the Ohio Revised Code, as well as
32 Article II, Section 2.03(5) of the County of Summit Charter, authorize the County Executive to
33 execute such agreements, subject to the approval of County Council; and

34
35 WHEREAS, the agreement of cooperation will cite the County of Summit's share of the
36 Project's construction cost as \$145,260.00; and

37
38 WHEREAS, no funds will be expended for the Project's construction and right-of-way
39 acquisition until and unless authorized by separate resolutions; and

41 WHEREAS, the Medina County Engineer that funds for this project will be needed in
42 2019; and

43
44 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
45 that authorizing the Executive to execute an agreement of cooperation with Medina County for
46 the Project is necessary and in the best interest of the County of Summit;

48 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
49 of Ohio, that:

4 SECTION 1

5
6 The County Executive is hereby authorized to execute an agreement of cooperation with
7 Medina County for the improvement of Medina Line Road, located in Copley Township and the
8 City of Norton, Council Districts 5 and 7 ("Project").

10 SECTION 2

11
12 The terms of the memorandum of agreement shall include the following:

- 13
14 a. That the parties estimate the Project's total cost to be \$2,690,000.00, with said cost
15 including construction engineering and inspection; and
16
17 b. The County of Summit will be responsible for 30% of the local share, Medina County
18 will be responsible for 50% of the local share, and the City of Norton responsible for
19 20% of the local share; and

21 c. That the net estimated cost to the County of Summit is \$145,260.00; and
22
23 d. The Medina County Engineer shall pay the local share of construction engineering
24 costs.

26 SECTION 3

27
28 This Resolution is hereby declared an emergency in the interest of the health, safety and
29 welfare of the citizens of the County of Summit, and for the further reason that it immediately
30 completes a prerequisite needed in order to apply for grant funding on a jointly owned roadway.

32 SECTION 4

34 Provided this Resolution receives the affirmative vote of eight members, it shall take
35 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
36 effect and be in force at the earliest time provided by law.

38 SECTION 5

40 It is found and determined that all formal actions of this Council concerning and relating
41 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
42 deliberations of this Council and of any of its committees that resulted in such formal action,
43 were in meetings open to the public, in compliance with all legal requirements, including Section
44 121.22 of the Ohio Revised Code.
