13 intergovernmental agreement with Summit County Children Services for a Family Drug Court
14 service provider contract, for the period 10/1/14 to 9/30/15, subject to confirmation by County
15 Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the agreement is necessary and in the best interest of the County of Summit;

25 The award by the Board of Control of an intergovernmental agreement with Summit
26 County Children Services for a Family Drug Court service provider contract, for the period
27 10/1/14 to 9/30/15, in the amount of \$55,488.00, is hereby confirmed and the County Executive
28 is hereby authorized to execute such agreement.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide for a social work program assistant effective 10/1/14.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.
