7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award from the Ohio Department of Mental Health and Addiction Services of a**
9 **Specialized Docket Payroll Subsidy Project grant, for the period 7/1/14 through 6/30/15, in**
10 **the amount of \$17,778.00, with no local cash match requirement, and appropriating grant**
11 **funds, for the Court of Common Pleas – Juvenile Division, and declaring an emergency.**

13 WHEREAS, the County of Summit Court of Common Pleas – Juvenile Division has been
14 awarded a grant from the Ohio Department of Mental Health and Addiction Services through the
15 Specialized Docket Payroll Subsidy Project, for the funding of individual salaries that are
16 assigned to specialty dockets, for the period 7/1/14 through 6/30/15, in the amount of
17 \$17,778.00, with no local cash match requirement; and

19 WHEREAS, this funding is to cover 20% of salary and benefit cost for the Courts Family
20 Drug Court Director; and

22 WHEREAS, this Council has determined by reviewing all pertinent information that it is
23 necessary and in the best interest of the County of Summit to authorize the Executive to execute
24 any documents necessary to accept the award of the aforementioned Specialized Docket Payroll
25 Subsidy Project grant from the Ohio Department of Mental Health and Addiction Services, and
26 to appropriate these grant funds;
