7 **A Resolution confirming an award by the Board of Control of a purchase contract with the**
8 **Metro Regional Transit Authority, as Best Practical Source, to provide transportation**
9 **services for work mandated recipients for the Executive's Department of Job and Family**
10 **Services, for a one-year term, from 01/01/15 through 9/30/15, in an amount not to exceed**
11 **\$187,500.00, with four options to renew for an additional one-year term, for the Executive's**
12 **Department of Job and Family Services, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held November 19, 2014, awarded a
15 purchase contract with the Metro Regional Transit Authority, as Best Practical Source, to
16 provide transportation services for work mandated recipients for the Executive's Department of
17 Job and Family Services, for a one-year term, from 01/01/15 through 9/30/15, in an amount not
18 to exceed \$187,500.00, with four options to renew for an additional one-year term, subject to
19 confirmation by County Council; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that the aforementioned purchase contract is necessary and in the best interest of the County of
23 Summit;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
26 of Ohio, that:

30 The award by the Board of Control of a purchase contract with the Metro Regional
31 Transit Authority, as Best Practical Source, to provide transportation services for work mandated
32 recipients for the Executive's Department of Job and Family Services ("DJFS"), for a one-year
33 term, from 01/01/15 through 9/30/15, in an amount not to exceed \$187,500.00, with four options
34 to renew for an additional one-year term, is hereby confirmed and the County Executive is
35 hereby authorized to execute such purchase contract.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and
40 welfare of the citizens of the County of Summit, and for the further reason to immediately
41 authorize the Executive to execute a necessary purchase contract to provide transportation
42 services for work mandated recipients for DJFS.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.




