7 **A Resolution authorizing the County Executive to execute Amendment #1 to a subgrant**
8 **agreement, as a representative of Workforce Investment Act Local Area 2, with the Ohio**
9 **Department of Job and Family Services and the Medina County Department of Job and**
10 **Family Services, for a Workforce Investment Act Local Area 2 grant for Workforce**
11 **Investment Act Disability Employment Initiative funds, to extend the subgrant agreement**
12 **through 12/31/14, for the Executive's Department of Job and Family Services, and**
13 **declaring an emergency.**

14
15 WHEREAS, Section 5101.21 of the Ohio Revised Code provides, commencing 7/1/08,
16 that the Ohio Department of Job and Family Services ("Ohio DJFS") may only make grants to
17 counties through subgrant agreements as described in that Section; and

18
19 WHEREAS, in conformance with Section 5101.21 of the Ohio Revised Code, Ohio DJFS
20 developed a standard subgrant agreement to be executed by the commissioners of each county
21 prior to receiving Ohio DJFS grant funds; and

22
23 WHEREAS, the County of Summit Department of Job and Family Services ("Summit
24 DJFS") and the Medina County Department of Job and Family Services ("Medina DJFS") have
25 previously executed the subgrant agreement for the Workforce Investment Act ("WIA") Local
26 Area 2's routine WIA funds for the period 7/1/11 through 6/30/13; and

27
28 WHEREAS, Ohio DJFS notified Summit DJFS and Medina DJFS that WIA Local Area 2
29 would be the recipient of \$6,967.00 annually in WIA Disability Employment Initiative ("WIA
30 DEI") funds, and has requested that Summit DJFS and Medina DJFS execute a subgrant
31 agreement governing receipt of those funds during the period 1/1/12 through 9/30/14; and

33 WHEREAS, County Council adopted Resolution No. 2012-185, which authorized the
34 County Executive to execute a subgrant agreement, as a representative of Local Area 2, with the
35 Ohio DJFS and Medina DJS for a WIA Local Area 2 grant for WIA DEI funds, during the period
36 of 1/1/12 through 9/30/14; and

37
38 WHEREAS, the United States Department of Labor ("USDOL" has offered Ohio an
39 opportunity to continue operating the WIAD DEI for three additional months, through 12/31/14,
40 a no-cost extension which allows Ohio to complete some of the project activities and to spend
41 the remaining funds; and

43 WHEREAS, in anticipation of USDOL's formal approval of the no-cost extension, Ohio
44 DJFS, Summit DJFS and Medina DJFS wish to execute Amendment #1 to the subgrant
45 agreement to extend the subgrant agreement through 12/31/14; and

47 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
48 that it is necessary and in the best interest of the County of Summit to authorize the County
49 Executive to execute Amendment #1 to the aforementioned subgrant agreement to extend the
50 subgrant agreement through 12/31/14;

4 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
5 of Ohio, that:

7 SECTION 1

8
9 The County Executive is hereby authorized to execute Amendment #1 to a subgrant
10 agreement, as a representative of Workforce Investment Act ("WIA") Local Area 2, with Ohio
11 DJFS and Medina DJFS governing the receipt of WIA Disability Employment Initiative funds by
12 WIA Local Area 2 during the period of January 1, 2012 through September 30, 2014. A copy of
13 said Amendment #1 to the subgrant agreement is attached hereto as Exhibit A and incorporated
14 herein by reference.

16 SECTION 2

18 This Resolution is hereby declared an emergency in the interest of the health, safety, and
19 welfare of the citizens of the County of Summit, and for the further reason that it is necessary to
20 immediately execute said Amendment #1 to the subgrant agreement so that the subgrant
21 agreement may be extended through 12/31/14.

23 SECTION 3

25 Provided this Resolution receives the affirmative vote of eight members, it shall take
26 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
27 effect and shall be in force at the earliest time provided by law.

31 It is found and determined that all formal action of this Council concerning and relating
32 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
33 deliberations of this Council and of any of its committees that resulted in such formal action,
34 were in meetings open to the public, in compliance with all legal requirements, including Section
35 121.22 of the Ohio Revised Code.
