10 **Pro Office software, under State Term Pricing, approved by the IT Board 11/18/14, in the**  
11 **amount of \$1,480.00 per month, for a total amount not to exceed \$88,800.00 for the 60-**  
12 **month period, for the Sheriff, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held November 19, 2014, awarded a  
15 purchase order with Graphic Enterprises Office Solutions, Inc., through De Lage Landen  
16 Financial Services, Inc., for a 60-month lease purchase agreement for eight copiers with  
17 ScanPath and PDF Pro Office software, under State Term Pricing, approved by the IT Board  
18 11/18/14, subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
21 that the purchase order is necessary and in the best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

28 The award by the Board of Control of a purchase order with Graphic Enterprises Office  
29 Solutions, Inc., through De Lage Landen Financial Services, Inc., for a 60-month lease purchase  
30 agreement for eight copiers with ScanPath and PDF Pro Office software, under State Term  
31 Pricing, approved by the IT Board 11/18/14, in the amount of \$1,480.00 per month, for a total  
32 amount not to exceed \$88,800.00 for the 60-month period, is hereby confirmed and the County  
33 Executive is hereby authorized to execute such purchase order.
