7 **A Resolution authorizing the County Executive to advertise for bids to provide food service**  
8 **to Detention Center youth, for the period 7/1/15 through 6/30/16, with four options to**  
9 **renew for an additional one-year term, for an estimated cost not to exceed \$300,000.00 for**  
10 **the first year, for the Court of Common Pleas – Juvenile Division, and declaring an**  
11 **emergency.**

12  
13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
14 requires this Council’s authorization for the County Executive to advertise for bids; and

15  
16 WHEREAS, the current food service contract for Detention Center youth will expire  
17 6/30/15, and the Ohio Department of Education, Office for Safety, Health and Nutrition, requires  
18 all entities receiving school lunch reimbursements that a procurement bidding process is  
19 required; and

20  
21 WHEREAS, a request is currently before the Board of Control to renew the current  
22 contract through 6/30/15; and

23  
24 WHEREAS, it is required that the new contract be in place by 7/1/15; and

26 WHEREAS, the Court of Common Pleas – Juvenile Division wishes that the Executive  
27 be authorized to advertise for bids for a new food service contract, for the period 7/1/15 through  
28 6/30/16, with four options to renew for an additional one-year term, for an estimated cost not to  
29 exceed \$300,000.00 for the first year; and

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
32 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
33 advertise for bids for a new food service contract, for the period 7/1/15 through 6/30/16, with  
34 four options to renew for an additional one-year term;

36 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,  
37 State of Ohio, that:

41 The County Executive is authorized to advertise for bids for to provide food service to  
42 Detention Center youth, for the period 7/1/15 through 6/30/16, with four options to renew for an  
43 additional one-year term, for an estimated cost not to exceed \$300,000.00 for the first year.

47 This Resolution is hereby declared an emergency in the interest of the health, safety and  
48 welfare of the citizens of the County of Summit and for the further purpose of immediately  
49 authorizing the County Executive to advertise for bids for the aforementioned food service  
50 contract.
