7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept the award by the Ohio Emergency Management Agency of a Fiscal Year 2015**  
9 **Statewide Search and Rescue Capability grant, for the period 7/1/14 through 6/30/15, with**  
10 **no local cash match requirement, in the amount of \$5,000.00, and appropriating these**  
11 **funds for Region 5 expenditures through 12/31/14, for the Executive’s Department of Law,**  
12 **Insurance and Risk Management – Division of Public Safety/Emergency Management**  
13 **Agency, and declaring an emergency.**

15 WHEREAS, the Ohio Emergency Management Agency has granted a Fiscal Year 2015  
16 Statewide Search and Rescue Capability grant award in non-federal funds in the amount of  
17 \$5,000.00, for the period 7/1/14 through 6/30/15, with no local cash match requirement, to the  
18 County of Summit Emergency Management Agency (“EMA”); and

20 WHEREAS, the purpose of the grant is to support Ohio urban search and rescue  
21 programs around the state to create a stronger search and rescue capability statewide and will be  
22 utilized to continue to build and sustain the Region 5 Type II collapse search and rescue  
23 capability; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
26 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
27 execute any documents necessary to accept the award of the aforementioned grant from the Ohio  
28 Emergency Management Agency, and to appropriate these search and rescue grant funds;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
31 of Ohio, that:

35 The County Executive is hereby authorized to execute any documents necessary to accept  
36 the Fiscal Year 2015 Statewide Search and Rescue Capability grant award from the Ohio

38 \$5,000.00, with no local cash match requirement.
