7 **A Resolution, pursuant to Section 177.13 of the Codified Ordinances of the County of**
8 **Summit, ratifying purchases and authorizing additional purchases from miscellaneous**
9 **vendors, for calendar year 2014, for the Executive and the Court of Common Pleas –**
10 **General Division, and declaring an emergency.**

12 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit
13 requires that purchases by an officeholder exceeding \$25,000.00 in aggregate in any calendar
14 year, where no additional competitive quotes or bids have been taken, shall be made only upon
15 authorization of County Council; and

16
17 WHEREAS, the County Executive requires various supplies, materials and equipment for
18 the operation of the departments under his authority; and

19
20 WHEREAS, the Executive's Department of Finance and Budget and the Board of
21 Control have previously approved purchases by the Executive in calendar year 2014 from My
22 Office Supplies, Inc., Akron Retread Service Co. d.b.a Akron Auto & Truck Tire, Mark – Glenn,
23 Inc. d.b.a. Park Ford, Shriber Auto Parts and Hach Company, for various items required by the
24 Executive, as set forth in Column 3 of Exhibit A, attached to this Resolution and incorporated
25 herein as if fully restated; and

27 WHEREAS, the Executive anticipates that he may make additional purchases from said
28 vendors during calendar year 2014, as set forth in Column 4 of Exhibit A; and

30 WHEREAS, the Executive's Department of Finance and Budget and the Board of
31 Control have previously approved purchases by the Court of Common Pleas – General Division
32 in calendar year 2014 from Community Drug Board, Inc. d.b.a. Community Health Center and
33 Matthew Bender & Company, Inc. for various items required by the Court, as set forth in
34 Column 3 of Exhibit A; and

36 WHEREAS, the Court anticipates that it will make additional purchases from
37 Community Drug Board, Inc. d.b.a. Community Health Center, as set forth in Column 4 of
38 Exhibit A; and

40 WHEREAS this Council finds and determines, after reviewing all pertinent information,
41 that it is necessary and in the best interest of the County to ratify purchases by the Executive and
42 the Court from miscellaneous vendors in calendar year 2014 and to authorize additional
43 purchases from said vendors for additional items during calendar year 2014;

45 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
46 of Ohio, that:

50 This Council hereby ratifies purchases by the County Executive and the Court of
51 Common Pleas – General Division from various vendors in calendar year 2014 as set forth in
52 Column 3 of Exhibit A, attached to this Resolution and incorporated herein as if fully restated.

11 This Resolution is hereby declared an emergency in the interest of the health, safety and
12 welfare of the citizens of the County of Summit, and for the further reason to immediately
13 provide necessary items for the Executive and Court of Common Pleas – General Division in
14 calendar year 2014.

18 Provided this Resolution receives the affirmative vote of eight members, it shall take
19 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
20 effect and be in force at the earliest time provided by law.

25 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
26 deliberations of this Council and of any of its committees that resulted in such formal action,
