7 **A Resolution authorizing the County Executive to execute a collective bargaining**
8 **agreement between Ohio Council 8 and Local 3885 of the American Federation of State,**
9 **County and Municipal Employees, AFL-CIO, and the County Executive and the County**
10 **Prosecutor's Child Support Enforcement Agency, for the period 10/1/14 through 9/30/17,**
11 **for the Executive and the Prosecutor's Child Support Enforcement Agency, and declaring**
12 **an emergency.**

14 WHEREAS, a collective bargaining agreement has been reached between the County
15 Executive and County Prosecutor's Child Support Enforcement Agency and Ohio Council 8 and
16 Local 3885 of the American Federation of State, County and Municipal Employees, AFL-CIO,
17 for the period 10/1/14 through 9/30/17; and

18
19 WHEREAS, said collective bargaining agreement provides for a 1.5% increase in pay
20 retroactive to 10/1/14, a 2.0% increase in pay for second year of the agreement, the period from
21 10/1/15 through 9/30/16, and a 2.25% increase in pay for the third year of the agreement, the
22 period from 10/1/16 through 9/30/17; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that the aforementioned collective bargaining agreement is necessary and in the best interest of
26 the County of Summit and the County Executive should be authorized to execute said collective
27 bargaining agreement;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that:

34 The County Executive is hereby authorized to execute a collective bargaining agreement
35 between Ohio Council 8 and Local 1229 of the American Federation of State, County and
36 Municipal Employees, AFL-CIO, and the County Executive and the County Prosecutor's Child
37 Support Enforcement Agency, for the period 10/1/14 through 9/30/17.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and
42 welfare of the citizens of the County of Summit and for the further purpose of providing a timely
43 collective bargaining agreement between Ohio Council 8 and Local 3885 of the American
44 Federation of State, County and Municipal Employees, AFL-CIO, and the Executive and the
45 Prosecutor's Child Support Enforcement Agency.


