7 **A Resolution authorizing the County Executive to execute a three-year policing contract**
8 **with the City of Green, in Council District 8, pursuant to which the County Sheriff will**
9 **provide the City of Green with Sheriff's Deputy/Sergeant and Direct Indictment Officer**
10 **hours, for the period 1/1/15 through 12/31/17, in exchange for payment by the City of**
11 **Green, of a total amount of \$7,079,829.13 during the three-year term of the contract, for**
12 **the Sheriff, and declaring an emergency.**

14 WHEREAS, County Council previously adopted Resolution No. 2012-013, which
15 authorized the County Executive to execute a three-year policing contract with the City of Green
16 in Council District 8, which expired on 12/31/14; and

17
18 WHEREAS, the City of Green has requested that the County of Summit enter into a new
19 contract pursuant to which the Sheriff will provide 33,362.04 deputy/sergeant hours, and 1,040
20 direct indictment officer hours for the period 1/1/15 through 12/31/17, and

21
22 WHEREAS, the City of Green has agreed to pay the County \$2,308,983.15 for the first
23 year, \$2,360,199.46 for the second year and \$2,410,646.52 for the third year, for a total amount
24 of \$7,079,829.13 during the three-year term of the contract; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that it is necessary and in the best interest of the County of Summit to authorize the County
28 Executive to execute for aforementioned policing contract with the City of Green;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that;

33 SECTION 1

35 The County Executive is hereby authorized to execute a three-year policing contract with
36 the City of Green, in Council District 8, pursuant to which the County Sheriff will provide the
37 City of Green with 33,362.04 deputy/sergeant hours, and 1,040 direct indictment hours for the
38 period of 1/1/15 through 12/31/17, in exchange for payment by City of Green in the amount of
39 \$2,308,983.15 for the first year, \$2,360,199.46 for the second year and \$2,410,646.52 for the
40 third year, for a total amount of \$7,079,829.13 during the three-year term of the contract.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and
45 welfare of the citizens of the County of Summit and for the further purpose of immediately
46 providing necessary policing for City of Green, in Council District 8, effective 1/1/15.
