7 **A Resolution appropriating funds totaling \$5,221,400.00 for all departments and agencies**
8 **of the County of Summit, with the exception of the Children Services Board, the Alcohol,**
9 **Drug Addiction and Mental Health Services Board and the Board of Developmental**
10 **Disabilities, to provide for the cost of a 27th pay period, for the Executive's Department of**
11 **Finance and Budget, and declaring an emergency.**

13 WHEREAS, the County Council's duties include the adoption of an annual operating
14 budget for the County of Summit; and

15
16 WHEREAS, Fiscal Year 2015 will have 27 biweekly pay dates, a cycle which last
17 occurred in 2004 and will next occur in 2026; and

18
19 WHEREAS, this Council previously adopted Resolution Nos. 2014-514 and 2014-515
20 approving and adopting the 2015 full operating budget for all funds, departments and agencies of
21 the County of Summit; and

22
23 WHEREAS, Resolution No. 2014-515 contained salary and benefit appropriations for the
24 normal 26 pay cycles for all departments and agencies of the County of Summit, with the
25 exception of the Children Services Board, the Alcohol, Drug Addiction and Mental Health
26 Services Board and the Board of Developmental Disabilities, and it is now necessary to
27 appropriate additional funds to allow for the cost of a 27th pay period in 2015; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that the aforementioned appropriations are necessary and in the best interest of the County of
31 Summit;

SECTION 5


