7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award from the Ohio Attorney General’s Office of a FFY 2015 Victims of Crime**
9 **Act grant in the amount of \$1,888.98, with no local cash match required, for the period**
10 **10/1/14 through 9/30/15, and appropriating funds, for the Prosecutor, and declaring an**
11 **emergency.**

13 WHEREAS, the County Prosecutor’s Office has received an award from the State of
14 Ohio Attorney General’s Office of a Federal Fiscal Year (“FFY”) 2015 Victims of Crime Act
15 (“VOCA”) grant in the amount of \$1,888.98, with no local cash match required, for the period
16 10/1/14 through 9/30/15; and

18 WHEREAS, the VOCA grant is to provide travel and training dollars for administrative
19 staff providing advocacy services to crime victims in Summit County; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
23 execute any documents necessary to accept the award of the aforementioned grant from the State
24 of Ohio Attorney General’s Office, and to appropriate these grant funds;

31 The County Executive is hereby authorized to execute any documents necessary to accept
32 the award of a Federal Fiscal Year (“FFY”) 2015 Victims of Crime Act (“VOCA”) grant in the
33 amount of \$1,888.98, with no local cash match required, from the State of Ohio Attorney
34 General’s Office, for the period 10/1/14 through 9/30/15.

28 121.22 of the Ohio Revised Code.


