7 **A Resolution confirming the award by the Board of Control of a professional service**
8 **contract renewal (first of two) with United Labor Agency, for employment services for**
9 **adults, dislocated workers and displaced homemakers, for the period 7/1/15 through**
10 **6/30/16, in an amount not to exceed \$963,318.00, for the Executive's Department of Job and**
11 **Family Services, and declaring an emergency.**

13 WHEREAS, County Council previously adopted Resolution No. 2014-281, which
14 authorized the County Executive to execute a professional service contract with United Labor
15 Agency, subject to the approval of the Board of Control, for employment services for adults,
16 dislocated workers and displaced homemakers, for the period 7/1/14 through 6/30/15, in an
17 amount not to exceed \$963,318.00, with two options to renew for an additional one-year term;

20 WHEREAS, the Board of Control, at its meeting held March 11, 2015, awarded a
21 renewal (first of two) of the aforementioned professional service contract with United Labor
22 Agency, for the period 7/1/15 through 6/30/16, in an amount not to exceed \$963,318.00; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that the renewal of the aforementioned professional service contract with United Labor Agency
26 is necessary and in the best interest of the County of Summit and that the Executive should be
27 authorized to execute said renewal;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

35 The award by the Board of Control of a professional service contract renewal (first of
36 two) with United Labor Agency, for employment services for adults, dislocated workers and
37 displaced homemakers, for the period 7/1/15 through 6/30/16, in an amount not to exceed
38 \$963,318.00, is hereby confirmed and the County Executive is hereby authorized to execute said
39 renewal.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the citizens of the County of Summit, and for the further reason to immediately
45 provide for the renewal effective of the professional service contract with the United Labor
46 Agency to provide employment services to allow it to continue providing employment services
