7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Mature Services, Inc., for Adult and Dislocated Worker employment**
9 **services, for the period 7/1/15 through 6/30/16, as Sole Source, in an amount not to exceed**
10 **\$200,000.00, for the Executive's Department of Job and Family Services, and declaring an**
11 **emergency.**

13 WHEREAS, the Board of Control, at its meeting held March 25, 2015, awarded a
14 professional service contract with Mature Services, Inc., for Adult and Dislocated Worker
15 employment services, for the period 7/1/15 through 6/30/16, as Sole Source, subject to
16 confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a professional service contract with Mature
27 Services, Inc., for Adult and Dislocated Worker employment services, for the period 7/1/15
28 through 6/30/16, as Sole Source, in an amount not to exceed \$200,000.00, is hereby confirmed
29 and the County Executive is hereby authorized to execute such contract.

31 SECTION 2

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for Adult and Dislocated Worker employment services effective 7/1/15.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,

49 121.22 of the Ohio Revised Code.


